Project Title: Coastal Development Permit (CDP) Application No. 22-01 for the Metro Bike Share Phase III OFW at Park and OFW at 30th Coastal Development Permit.



Project location: The Metro Bike Share Phase III OFW at Park and OFW 30th Project (Project) is located north western intersection of Ocean Front Walkway and Park Avenue and on the southwestern intersection of Ocean Front Walk and 30th Avenue within the Venice Coastal Zone-Specific Plan, as shown in *Figure 1 - Project Site Location Map*. (City of Los Angeles, 2022).

Project Background: The Metro Bike Share is a shared, rent a bike program that is provided to residents and visitors in the City of Los Angeles. The system was designed to provide a first mile/ last mile connection between all modes of transportation which includes but is not limited to walking, bus trips and train trips. The goal is to continue to expand on an environmentally friendly mode of transportation. The Metro Bike Share system currently has 224 stations in over three (3) service areas which include North Hollywood, the Westside and Downtown Los Angeles/Central Los Angeles. The Project site is located approximately 0.3 miles from the Pacific Ocean within the dual jurisdiction of the California Coastal Zone. The City of Los Angeles Municipal Code (LAMC) § 12.20.2 applies to projects within the California Coastal Zone.

Project Description: The proposed Project includes two (2) bike share stations to be installed along the Venice Beach bike path and Ocean Front Walk (OFW) on environmentally safe plastic tiles. A total of 32 bicycle spaces will be installed.

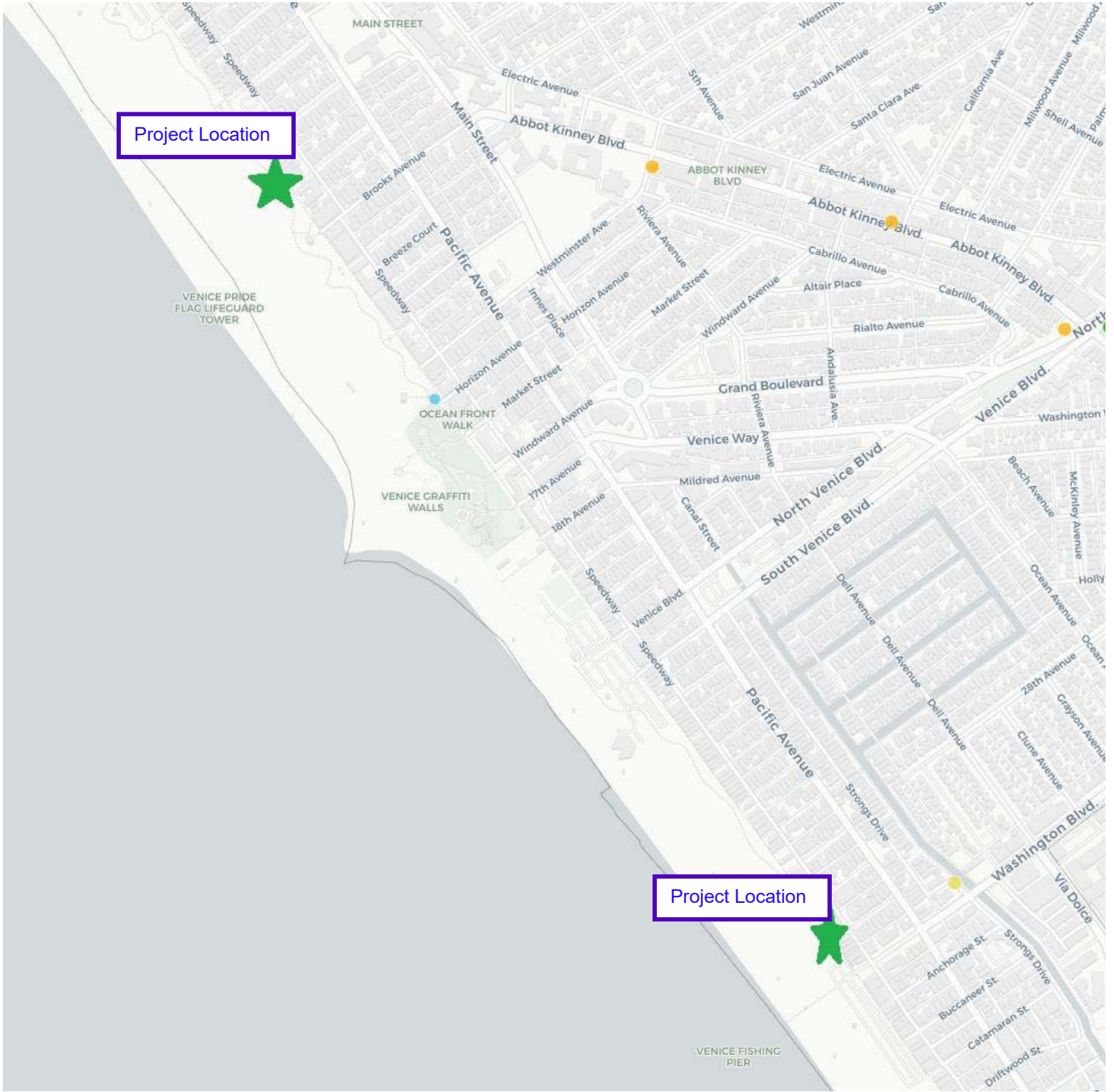


Figure 1
